An application for site alteration has been made by Rankin Construction Inc. on behalf of P. Budd Developments Inc. to import 35,000m3 (roughly 3500 truckloads) of fill to the property legally described as Plan M94 Lot 1 Plan 30M300; PT Lots 12 and 13 and RP; 30R15516 Parts 1 and 2 (off of South Grimsby 5 Road) in Smithville, north of the CP Rail Line. This is currently a vacant lot owned by P. Budd Developments Inc.

The applicant has expressed that an estimated 35,000m3 (roughly 3500 truckloads) of fill will be imported to the site to grade the land to the proposed pre-grading plan in preparation for a future subdivision plan (currently draft plan approved).
